Subject: Last Date of Admission and Fee Refund Policy for Admissions to Academic Year 2026-27

Reference:

1. UGC Notification on Refund of Fees and Non-Retention of Original Certificates, October 2018.
2. UGC D.O. No. F.2-71/2022 (CPP-II) (C-114546) dated 12 June 2024 regarding Fee Refund Policy, read with subsequent communications issued by the University Grants Commission from time to time.

In pursuance of the above UGC Notification and Guidelines, read with subsequent communications issued by the University Grants Commission from time to time, and with the approval of the **Hon'ble University Management**, it is hereby notified for the information and compliance of all concerned that the University hereby formally notifies **31 August 2026** as the Last Date of Admission for all eligible academic programmes offered by Dnyaan Prasad Global University, for the Academic Year 2026-27.

Accordingly, the following Fee Refund Policy shall be applicable in respect of cancellation/withdrawal of admissions for the Academic Year 2026-27.

Fee Refund Schedule

Sr. No.	Percentage of Refund of Fees	Point of Time when Notice of Withdrawal of Admission is Received
1	100% (after deduction of Processing Fee of ₹1,000/- only)	15 days or more before the formally notified last date of admission
2	90%	Less than 15 days before the formally notified last date of admission
3	80%	15 days or less after the formally notified last date of admission
4	50%	More than 15 days but within 30 days after the formally notified last date of admission
5	Nil	More than 30 days after the formally notified last date of admission



General Instructions

1. This Notification shall be applicable to all eligible **First Year admissions** to the programmes offered by the University for the Academic Year 2026-27, unless otherwise prescribed by the respective statutory or regulatory authority.
2. Applications for cancellation/withdrawal of admission shall be submitted along with all required supporting documents to the **Admission Department/Student Section** of the respective School.
3. The University shall **not retain the original academic certificates** of students and shall comply with the applicable UGC provisions relating to verification and return of original documents.
4. In the event that the Last Date of Admission is revised or extended by the University in accordance with the directions issued by the UGC or any other competent statutory/regulatory authority, the corresponding Fee Refund Schedule shall stand revised accordingly without requiring issuance of a separate notification and shall be applicable accordingly.

All Deans, Directors, Heads of Schools, Admission Department/Teams, Finance & Accounts Section, ERP Cell and all other concerned stakeholders are hereby directed to ensure strict compliance with this Notification.
